It does that by facilitating the transportation of food through linkages established between food sources, such as farmers and grocery stores, and emergency food providers, i.e. food banks, Meals on Wheels, and preventing the waste of 40% of such food by delivering it to those who are "food insecure" - that is, who have no reliable food supply. "One in three children, one in five adults, and one in six senior citizens are food insecure".
