F.O.T.C.A. Has organized local and international music presentations for the Verde Valley Region as cultural education. Supports regional community services such as protecting the Verde River.

TEWA Holiday Projects volunteers delivered eighty-five "baskets" of food and personal hygiene items to the TEWA elders. They provided one hundred fifty brand new wrapped gifts to the Village of TEWA as well as a very large amount of used donated clothing for the village.
